UNDERGRADUATE TRANSCRIPT: EXPLANATORY NOTES

The record of learning and achievement for each student is issued when they leave the University.

The record known as the transcript is based on an agreed data set, which accords with the guidance issued by the UK Quality Assurance Agency (QAA).

KEY TO THE INFORMATION

1. Student name as given by the individual and registered on the Student Records System.
2. Registration Number: the student identifier designated on registration.
3. Date of birth: as given by the student on their enrolment form.
4. HESA Number: the unique national identifier allocated for purposes of anonymised reporting to the UK's Higher Education Statistics Agency (HESA).
5. Qualification: the validated course name giving intended award of study (the course the student registered for). The actual award given will be detailed at the bottom of the page, along with the date of award.
6. Programme of Study: the course of study which the student registered for.
7. Route of Study: an approved programme of study within a named award.
8. Pathway Code: the pathway code on the Student Records System.
9. Language of instruction: this specifies the language the course was taught in. The language of assessment will always be English with the exception of language courses.
10. Mode of Study: details the mode of study on completion of the course. Eg F/T – full-time; P/T – part-time and S/W – sandwich course.
11. Level of Qualification: the final level of the academic award achieved benchmarked to the QAA's Framework for Higher Education Qualifications (FHEQ) below:

12. Level of Module: the FHEQ level of each module grouped by level rather than in date order.
13. Module Code and Title: the module code identifies the University site/Faculty/School (first character); the subject area (the following three characters); the level of study (fifth character) and the reference for each validated module studied (sixth and seventh characters).
14. Credits: the academic credit weighting for each module.
15. Session/Semester: the academic session and semester in which each module was studied (eg 2015 means 2015/16).

Semester 1 – September to December,
Semester 2 – January to March,
Semester 0 – Year long modules,
Semester 3 – Summer School,
Semester 9 – Re-assessment Period
16. Result: Passed with an overall mark of at least 40%. Condoned Passed (or Credit) is a mechanism by which a module can be passed and credit can be awarded even where the module pass mark or a qualifying mark, and thus the module learning outcomes, have not been achieved. The University of Westminster Condonement regulations changed in 2010/1 and 2016/7. Students who commenced studies prior to 2010/1 are normally allowed to count one condoned credit module towards their credit total at each level. Students who commenced studies in 2010/1 are normally allowed 45 condoned credits at level 3 or 4 only. Students who commenced studies in 2016/7 are normally allowed 40 condoned credits at level 3 or 4 only.
17. Attempt: 1 means first registration for the module; 2 means second registration or further attempt following failure at the first attempt.
18. Mark: the overall or aggregate mark for the module as a percentage.
19. P: Inclusion of P in the module code indicates language study within the University-wide Polylang scheme. The academic credits for such modules are awarded at the same level as the student's main study programme.
20. RPL: Recognition of Prior Certified (RPCL) and/or Experiential (RPEL) Learning. When academic credit is awarded for prior learning the student is granted exemption from the module(s) to which the RPL has been benchmarked.
21. ECTS: European Credit Transfer System. 15/20 University of Westminster Undergraduate credits is the equivalent of 7.5/10 ECTS credits. Students who complete one or two semesters in a partner institution with funding support through the EU Student Mobility Scheme (ERASMUS) are awarded transferable credits whose value is formally recognised within the EU member states.
